

Hua Ho MasterCard Platinum Booster Rebate Promotion (the “Promotion”) Terms and Conditions (the “Terms and Conditions”):

1. Term

1.1 This Promotion is valid from 30 January to 5 February 2019 and 17 to 18 February 2019 (the “Promotion Period”).

2. Eligibility & Benefits

2.1 Guaranteed Rebate

2.1.6 Any transaction reversal will be excluded from this Promotion.

2.1.7 The rebate shall only be credited to the Hua Ho Mastercard Platinum if the account is in good standing and valid on the day of credit.

2.1.8 Standard Chartered Bank shall not accept any responsibility for the services and products offered by merchants in any of the spend categories. The services and products are the responsibility of these merchants and are subject to their terms and conditions.

2.1.9 In the event of closure of the Hua Ho Mastercard Platinum within 6 months of the rebate being provided, the bank reserves the right to claw back the rebate whether it was utilised or not.
