



## **Kure Oxygen Water x StanChart Promotion (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):**

### **1. Term**

1.1 This Promotion begins on 12 April 2021 to 31 May 2021 (“**Promotion Period**”).

### **2. Eligibility & Benefits**
