



StanChart x ZALORAYA 2021 Promotion (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):

1. Term

- 1.1 This Promotion is organized by Standard Chartered Bank (the “**Bank**”)
- 1.2 This Promotion begins on 1 April 2021 until 31 May 2021 (“**Promotion Period**”).

2. Eligibility & Benefits

StanChart x ZALORAYA 2021 Promotion

2.1.1 The Promotion is open to the following clients of the Bank (collectively referred to as “**Eligible Clients**”):

- new Standard Chartered cardholder; and/or
