

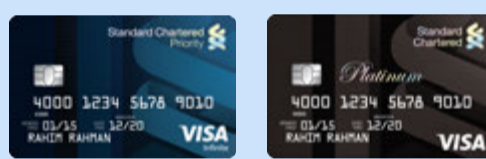

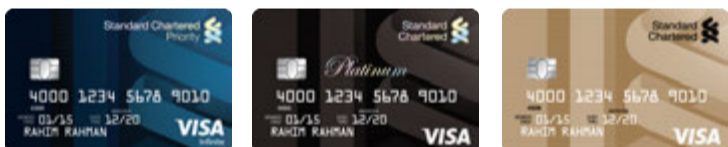

Terms and Conditions:

- 1. Term**
 - 1.1 This Promotion is valid from 3rd April to 3rd May 2022, both days inclusive ("Promotion Period").
- 2. Eligibility & Benefits**
 - 2.1 This Promotion is only open to Standard Chartered Visa Credit cardholder who spend a minimum of BND 38 in a single transaction during the Promotional Period ("Eligible Client or Eligible Clients").
 - 2.2 Eligible clients will receive a:
 - a) 22% discount coupon for their next Pocket or HeyDomo purchase using Standard Chartered Visa Infinite and Platinum Credit Cards.
 - b) 12% discount coupon for their next Pocket or HeyDomo purchase using Standard Chartered Visa Gold and Classic Credit Cards.
 - 2.3 To qualify for this Promotion, all transactions must be made via Pocket or HeyDomo applications with their participating merchants listed at pocket.com.bn and heydomo.com.
 - 2.4 Each Eligible Client is entitled to one coupon per week each from Pocket and Heydomo throughout the Promotion Period.
 - 2.5 The discount coupon will only be issued once a transaction is successfully made.
 - 2.6 The discount coupon can only be used on the next purchase and the amount is capped at BND 38.
