



StanChart x ZALORA 2022 Promotion (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):

1. Term

- 1.1 This Promotion is organized by Standard Chartered Bank (the “**Bank**”)
- 1.2 This Promotion begins on 14 January – 31 December 2022 (“**Promotion Period**”).

2. Eligibility & Benefits

2.1 The Promotion is open to the following clients of the Bank (collectively referred to as “**Eligible Clients**”):

- new Standard Chartered cardholder; and/or
- be an existing Standard Chartered cardholder;
- have created an account with the online merchant, ZALORA Malaysia (“new Zalora User”);
- have an existing account with the online merchant, ZALORA Malaysia (“existing Zalora User”)
- spend with their Standard Chartered card during the Promotion Period;

2.1.1 The Promotion is valid only for online transactions made on www.zalora.com.my or the ZALORA mobile application in Brunei/Malaysia.
