

Hua Ho Ramadhan Discount (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):

1. Term

1.1 This Promotion is valid on 27 and 30 May 2019 only (“Promotion Period”).

2 Eligibility & Benefits

2.1 Standard Chartered Hua Ho Mastercard Platinum whose purchases at Participating Hua Ho Outlets with a total of minimum of BND100 in a single receipt will enjoy 35% discount off their bill.

2.2 The discount is capped at BND50 per transaction per cardholder each day.

2.3 The discount is applicable for each department store and supermarket purchases at Participating Hua Ho Outlets per day.

2.4 Splitting of bills is prohibited. Discount will be eligible for **both primary and supplementary cardholders** on separate purchases. (For example, the primary card holder and supplementary cardholder **cannot** avail the discount on the same item and have the purchase split on both cards, but if each primary and supplementary cardholder has accumulated their own purchases, each credit card will be eligible for one discount claim per credit card.)

2.6 The discount will not be applicable if the Standard Chartered Bank credit card rewards voucher is redeemed for payment.
