1. Term

2 Eligibility & Benefits

2.1 Instant Dip for Credit Card Signup

- 2.1.1 The instant dip is only applicable for customers who do not have a valid Standard Chartered credit card and [A] make purchase in accordance with Clause 2.1.2 below / [B] apply for Standard Chartered credit card during the Promotion Period.
- 2.1.2 Customers who make purchases worth at least BND100 in a single receipt through any mode of payment other than Standard Chartered cards at any outlets at the Mall will be eligible for an instant dip when they submit a leads form at the Standard Chartered Bank (Brunei) booth.
- 2.1.3 Customers must present their sales slip to be eligible for the instant dip. The premiums for the instant dip are subject to availability on a first-come-first serve basis.
