

iBeautyParlour EasyPay Sale (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):

1. Term

1.1 This Promotion is valid from 13 July to 31 August 2019 (“Promotion Period”).

2 Eligibility & Benefits

EasyPay Rebate

- 2.1 Standard Chartered Visa Credit Cardholders who use their Standard Chartered credit cards will be eligible to a rebate if they convert their purchases to an EasyPay during the promotional period.
- 2.2 Clients with a new Standard Chartered Visa credit card which was registered under the “Sign up with Visa” promotion will be eligible for a BND50 rebate when they make a minimum purchase of BND300 from iBeautyParlour during the promotion period and convert their purchase to a 0% EasyPay instalment plan. This is limited to the first 25 clients.

- 2.10 The rebate will be credited back to cards which are in good standing at the time of credit.
