

MyBillPayment Credit and Double Rewards Promotion (“this Promotion”) Promotion Terms and Conditions (“these Terms and Conditions”):

1. Term

1.1 This Promotion is valid from 1 April to 30 June 2019 (“Promotion Period”).

2. Eligibility & Benefits

2.1 Standard Chartered Bank cardholders who purchase prepaid top-up via MyBillPayment app, version 3.0 (“MBP App”) with their Standard Chartered credit or debit cards will be eligible to earn online credits (“Credit”) and/or double credit card reward points during the Promotion Period.

2.2 This Promotion is applicable for purchase of the following prepaid top-ups:

- DST Easi Prepaid Card
- Progresif Topup
- POWERInstant
- Apple iTunes Gift Card
- Google Play Gift Card

2.3 MBP App Credit

2.3.1 Every BND100 spent on top-up through the MBP App will earn a Credit of BND1 capped at BND5 per MBP registered member per month.

2.3.2 The Credit will be applied to the first purchase made after the first 3 days of the following month.

2.3.3 The Credit will expire on the last day of the month of credit by 23.59pm. Upon expiry, any unutilized Credit will be forfeited and will not be extended under any circumstance.

2.3.4 Should there be a reversal of the purchase made during the Promotion Period, the Credit will be deducted from the card account utilized to purchase the top-up.

2.3.5 Standard Chartered Bank shall not accept any responsibility for the services and products offered by ThreeG Media Sdn Bhd. The services and products are the responsibility of ThreeG Media Sdn Bhd and are subject to their terms and conditions.

2.4 Double Reward Points
