

Sabre Brunei Travel Fair (“this Promotion”) Terms and Conditions (“these Terms and Conditions”):

1. Term

1.1 This Promotion is valid from 6 to 7 October 2018 (“Promotion Period”).

2 Eligibility & Benefits

2.1 Credit Card Signup Gift

- 2.1.1 The instant dip is only applicable for customers who do not have a valid Standard Chartered credit card during the Promotion Period.
- 2.1.2 Customers who make purchases worth at least BND300 in a single receipt through any mode of payment other than Standard Chartered cards at the Sabre Brunei Travel Fair (“Travel Fair”) will be eligible to receive a Standard Chartered corporate premium when they submit an application for a Standard Chartered credit card at the Standard Chartered Bank booth.
- 2.1.3 The premiums are limited to the first 100 applications received on a first-come-first serve basis.
- 2.1.4 Customers who apply for a Standard Chartered credit card during this Promotion will also be entitled to offers from A Year’s Worth of Holiday Promotion if they comply with the applicable terms and conditions.
- 2.1.5 Should the credit cards applied during this Promotion be cancelled by the customers less than 12 months from when the cards were approved, then the bank reserves the right to charge for the signup gift which was previously obtained during the Promotion.

2.2 Triple Reward Points for Royal Brunei Ticket Purchases

- 2.2.1 Standard Chartered Credit Cardholders who spend a minimum of BND1000 in a single receipt at the Travel Fair during the Promotion Period on Royal Brunei air tickets will be eligible for 3x reward points.
- 2.2.2 Standard Chartered Credit Cardholders will be required to present their sales slip, credit card and Royal Brunei air tickets for verification in order to register for the additional reward points at the Standard Chartered Bank booth at the Travel Fair.
- 2.2.3 The additional reward points are limited to 1,000 per cardholder during the Promotion Period.
- 2.2.4 The additional reward points will be credited to eligible credit card accounts the following month after the Promotion Period.
- 2.2.5 Should there be any cancellation or reversal of the credit card transaction in clause 2.2.1 within 3 months of the transaction then the bank will have the right to claw-back the additional reward points from the account without prior notice.
- 2.2.6 Standard Chartered Bank shall not accept any responsibility for the services and products offered by Royal Brunei. The services and products are the responsibility of Royal Brunei and are subject to their terms and conditions.

2.3 Guaranteed Instant Lucky Dip for Credit Card Purchases

- 2.3.1 Standard Chartered Credit Cardholders who spend a minimum of BND1000 in a single receipt at any travel agents participating at the Travel Fair will be eligible for a guaranteed instant lucky dip.
- 2.3.2 Standard Chartered Credit Cardholders will be required to present their sales slip and credit card for verification in order to participate in the instant dip at the Standard Chartered Bank booth at the Travel Fair.
- 2.3.3 The instant dip is limited to the first 100 cardholders where each cardholder is entitled to one dip only throughout the Promotion Period.
- 2.3.4 The instant dip prizes comprise of the following:

2.4 0% EasyPay Instalment Plan

- 2.4.1 Standard Chartered credit cardholders who make any purchase using their credit card at this Promotion, and choose to convert the purchase into a 6-month or 12-month 0% EasyPay Instalment Plan, will enjoy waiver on the processing fee for the aforementioned EasyPlan Instalment Plans only.
- 2.4.2 The processing fee is applicable for up to 30 days from date of purchase.

- 4.4 In the case of any disputes arising from or in connection with this Promotion, our decision is final and conclusive.
- 4.5 The Terms and Conditions are in addition to our terms and conditions on which we provide our products including the Customer Terms, Credit Card Terms and any other documents forming our banking agreement.
