



Members Get Members (MGM) Offer

THE RULES: "JOIN ME AT THE DIGITAL BANK"

I. RATIONAL

Standard Chartered Bank is launching a referral program called "**referral offer**" for its individual customers. By referring Standard Chartered Bank to one or more of his physical friends and family members, the client who referred will win a prize.

Definition

The Godfather: Any existing to bank client of Standard Chartered Bank and who share his godfather's code to his relatives who may be interested and who maintains his account according to the terms and conditions of the bank.

Referral code: Unique code available to all existing SCB customers and transmitted by SMS by the bank, which can also be available in their personal login area of the SC Mobile application.

The Godchild: Any individual whose first application is done in the context of this referral offer. This person will use the referral code of his or her godfather and will initiate his or her current account opening.

II. DURATION

The referral offer will begin on September 15th 2021, and end on December 31st, 2021. During this period, the program rules will be available at sc.com/ci. Standard Chartered Bank reserves the right to modify, shorten, or extend the referral offer if circumstances so require, after informing its clients via email and on the official Facebook page of Standard Chartered Bank Côte d'Ivoire.

III. TERMS & CONDITIONS

a. Who can participate ?

- Any individual aged of 18 years and above, who holds one or more accounts with Standard Chartered Bank with a minimum balance of FCFA **50,000** and who maintains their accounts according to the terms and conditions previously signed.
- By referring their relatives, all participants will be deemed to have accepted without exclusion and declare to be bound by these terms and conditions.
- Companies and non-governmental organizations are not eligible for this promotion.

- All customers who selected the option to not be contacted for a marketing campaign (DnD) are not eligible. To change status and be eligible to participate, unselect the option via SC Mobile app.
- More specifically, no participant must have been convicted, prosecuted or suspected of any crime related to the fight against money laundering, fraud and terrorism.
- Persons involved in the organization and implementation of within Standard Chartered are excluded.

b. How to participate ?

- No entry form is necessary, each existing client of the bank "godfather" will identify in his environment and share his godfather's code so that his relatives (friends, colleagues, family etc. ...) use it when creating their account* (s).
- The "godchild" will use his godfather's code to open his current account in the fields indicated and will proceed with the normal account opening process via SC Mobile.
- Once the account is opened*, the "godchild" will fund his current account with a minimum of 50.000 FCFA within one (1) month.

* The account opening is subject to validation by the bank according to its usual procedures.

c. Winner' selection

- The "godfather" whose godchild(ren) will have completed their account opening and funded their current account with a minimum amount of 50 000 FCFA, will be credited for each of his godchild(ren) the sum of 5 000 FCFA.
 - The bank will take care to validate at the end of each month the credit of the sponsored persons in order to reward the sponsor.
 - The credit of 5.000FCFA will be done at the latest the 2nd week of the month.
 - All deposit transactions: cash, transfers received from other banks or "mobile money" accounts, cheque remittances and made by the client are eligible.
- NB: The bank reserves the right to reconcile and assess split transactions for validation.
- For a customer who opens several current accounts or makes several deposits, the sum of the day's deposits will be considered.

For example:

If the client holds accounts X and Y and deposits, on the day 50,000 (fifty thousand) FCFA on account X and 50,000 (fifty thousand) FCFA on account Y, the total deposits considered for the client on day 1 will be 100,000 (One hundred thousand) FCFA.

If the client deposits 70,000 (seventy thousand) CFA francs at 9:00 a.m. and then 30,000 (thirty thousand) CFA francs at 1:00 p.m., the total considered deposits for the client on that day will be 100,000 (one hundred thousand) CFA francs.

- By participating, the customer consents to and gives SCB the right to publish his/her name, image in all publications related to this program; SCB is not required to seek any additional consent.

- By accepting the prize, the winners authorize SCB to use their name, first name and image in any professional event of the bank, without this use giving rise to any right to compensation other than the prize won.

IV. PROTECTION OF PERSONAL DATA

It is expressly agreed that, in the context of this program and in the event of processing of personal data, Standard Chartered Bank will act in accordance with Law No. 2013-450 of 19 June 2013 on the protection of personal data.
