Standard Chartered PLC (“**SC**”) announces that it has purchased the following number of its ordinary shares of US\$0.50 each on the London Stock Exchange through J.P. Morgan Securities plc.

SC intends to cancel the purchased shares.

Following the purchase of these shares, SC will have 3,306,877,851 ordinary shares in issue. Therefore, the total voting rights in SC will be 826,719,462. This figure for the total number of voting rights may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, SC under the FCA’s Disclosure Guidelines and Transparency Rules.

SC holds no shares in Treasury.

This issued share capital figure reflects a difference of 82,374 ordinary shares arising from employee share scheme exercises and which, due to an administration error was not factored into the announcement made on 7 May 2019.
