

**Terms and Conditions for 2020 Standard Chartered – Disney and Pixar’s Toy Story’s 25<sup>th</sup> Anniversary Promotion – Instant Fund-in Offer at Selected Branch (the “Instant Fund-in Offer”)**

1. Unless otherwise specified, the Instant Fund-in Offer period is from 3 September to 1 November 2020 (both dates inclusive) (“**Instant Fund-in Offer Period**”).
2. Clients must fulfil the following requirements during the Instant Fund-in Offer Period in order to be eligible for one Limited Edition Disney and Pixar’s Toy Story 4 Stainless Steel Straw Set (“**Straw Set**”):
  - i. Successfully apply for / hold a valid Standard Chartered Disney ATM Card (“**Disney ATM Card**”); AND
  - ii. Open a Designated Account (as defined in the 2020 Standard Chartered – Disney and Pixar’s Toy Story’s 25<sup>th</sup> Anniversary Promotion Terms and Conditions); AND
  - iii. Sign up for Priority Banking/Premium Banking/Easy Banking; AND
  - iv. Successfully take a picture with the Toy Story Statue at selected branches (the “**Statue Picture**”) and immediately upload it to the client’s Facebook (“**Toy Story 25th Anniversary Photo Moment**”); AND
  - v. Deposit at least HKD10,000 and less than HKD100,000 into the Designated Account upon account opening and maintain the deposit until 31 December 2020.
3. Clients must fulfil the following requirements during the Instant Fund-in Offer Period in order to be eligible for one Limited Edition Disney and Pixar’s “Toy Story 4” Dinnerware Set for 1 person (“**Dinnerware Set**”):

4. The Straw Set and the Dinnerware Set can be collected at the selected branch on the date upon account opening and are subject to stock availability.

9. **If a client has redeemed the Straw Set or the Dinnerware Set but thereafter cancels the relevant Disney ATM Card or fails to fulfil the respective requirements (as stipulated in Clause 2 or 3 above), at Standard Chartered Bank (Hong Kong) Limited’s (the “Bank”) discretion, an administration fee of HKD200 or equivalent (applicable to the redemption of one unit of the Straw Set (offered under Clause 2), HKD400 or equivalent (applicable to the redemption of one unit of Dinnerware Set) (offered under Clause 3) will be debited from any of his/ her deposit account(s) with the Bank without prior notice.**

The Bank and The Walt Disney Company (including its parent, affiliates or subsidiaries) shall bear no liability relating to any aspect of the Straw Set and the Dinnerware Set, including without limitation, their quality, the supply, the descriptions of goods and/or services provided by the supplier, any false trade description, misrepresentation, mis-statement, omission, unauthorized representation, unfair trade practices or conduct in connection with the Straw Set and the Dinnerware Set under the offer, by the supplier, its employees, officers or agents. The Straw Set and the Dinnerware Set may be subject to additional terms and conditions of the supplier.
11. Please check the Straw Set or the Dinnerware Set upon collection at the branch. Defective products will be replaced once only and subject to stock availability. Damage in the packaging or caused artificially on the product will not be accepted for replacement. No replacement or exchange of the Straw Set or the Dinnerware Set will be accepted or catered after the date of collection.

To the extent permitted by law, the Bank and The Walt Disney Company (including its parent, affiliates or subsidiaries) shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of accepting or using the Straw Set or the Dinnerware Set.
13. Clients acknowledge and agree to the collection of the Statue Picture by the Bank. Clients further acknowledge and agree that their image in the Statue Picture may be featured in materials and works in promotional programmes of the Bank that are related to the Instant Fund-in Offer. Clients acknowledge that there are intellectual property rights in the Toy Story Statue and agree not to do or omit to do or permit to be done any act which will alter or damage the Toy Story Statue. Clients also acknowledge and agree that the Bank owns all rights, title and interest (including but not limited to the intellectual property rights) in and to the Statue Picture. Clients agree not to do, or omit to do or permit to be done any act which will alter the Statue Picture, and the Bank shall bear no liability relating to any aspect of the Statue Picture and its altered version.
17. The Bank reserves the right to alter, extend or terminate the above offers and amend the terms and conditions at any time. In case of disputes, the decision of the Bank shall be final and binding.
18. If there is any inconsistency or conflict between the English and Chinese versions of these terms and conditions, the English version shall prevail.
