 - *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

That resolution authorises the issuer to make purchases of its ordinary shares (subject to certain conditions) until the end of its 2020 annual general meeting, but during that period the issuer may agree to purchase shares where the purchase may not be completed (fully or partly) until after the authority ends, so as to enable the issuer to make a purchase of ordinary shares in accordance with any such agreement as if the 2019 authority had not ended.
