Standard Chartered PLC (“**SC**”) announces that today it purchased the following number of its ordinary shares of US\$0.50 each from J.P. Morgan Securities plc (“**JPM Securities**”), pursuant to the share buy-back programme previously outlined on 3 August 2021 and detailed in the announcement of 3 August 2021 (the “**Programme**”).

Following the cancellation of the purchased shares, SC will have 3,115,381,863 ordinary shares in issue. Therefore, the total number of voting rights in SC will be 778,845,465.

Any share purchases pursuant to the Programme will be effected in accordance with certain pre-set parameters and limits, and in accordance with applicable law and regulation as described in more detail in SC’s announcement of 3 August 2021.

In accordance with Article 5(1)(b) of Regulation (EU) No. 596/2014 (as incorporated into UK domestic law by the European Union (Withdrawal) Act 2018), a full breakdown of the individual trades is attached to this announcement.
