Voting Rights and Capital

The following notification is made in accordance with the UK Financial Conduct Authority's Disclosure Guidance and Transparency Rule 5.6.1.

At close of 30 June 2021 the issued share capital of Standard Chartered PLC consisted of:

3,119,033,863 ordinary shares of US\$0.50 each with voting rights of one vote for every US\$2 nominal value;

99,250,000 8¹/₄ per cent non-cumulative irredeemable preference shares of £1 each with no equity voting rights;

96,035,000 7³/₈ per cent non-cumulative irredeemable preference shares of £1 each with no equity voting rights;

7,500 6.409 per cent non-cumulative redeemable preference shares of US\$5 each with no equity voting rights;

7,500 7.014 per cent non-cumulative redeemable preference shares of US\$5 each with no equity voting rights.

The total number of voting rights in Standard Chartered PLC is 779,758,465. Ordinary shareholders have one vote for every four ordinary shares they hold (equivalent to one vote for every US\$2 nominal value of ordinary shares). This may be used by shareholders to determine the percentage of voting rights they hold in Standard Chartered PLC and if they are required to notify their interests, or a change to their interest, in Standard Chartered PLC under the UK Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
