 - *the securities are of the same nominal value with the same amount called up or paid up;*
 - *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
 - *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

That resolution authorises the issuer to make purchases of its ordinary shares (subject to certain conditions) until the end of its 2021 annual general meeting, but during that period the issuer may agree to purchase shares where the purchase may not be completed (fully or partly) until after the authority ends, so as to enable the issuer to make a purchase of ordinary shares in accordance with any such agreement as if the 2020 authority had not ended.
