

**Terms and Conditions of QR Cash x JETCO Cardless Withdrawal Promotion 2020 (the “Promotion”):**

1. The promotion period is from 12 August 2020 to 31 January 2021, both dates inclusive (the “**Promotion Period**”).
2. The Promotion is applicable to the first 4,000 clients (each an “**Eligible Client**”) of Standard Chartered Bank (Hong Kong) Limited (the “**Bank**”) who have successfully conducted QR Cash cardless withdrawal via SC Mobile app for the first time at Standard Chartered ATMs or JETCO ATMs (the “**Eligible Withdrawal**”) during the Promotion Period (the “**Eligible Requirement**”).
3. An Eligible Client who has made the Eligible Withdrawal will be entitled to HKD30 OpenRice Promo Code (the “**Prize**”).
4. Each Eligible Client can only enjoy the Prize ONCE, regardless of the number of Eligible Withdrawals made during the Promotion Period.
5. The Prize is available on a first-come-first-served basis while quota lasts.
6. All Eligible Clients, upon fulfilment of the Eligible requirement, will be enrolled in the Promotion automatically without further registration in accordance with these Terms and Conditions.
7. The Bank reserves the right to offer an alternative reward and verify the Eligible Client’s transaction records in considering the Eligible Client’s eligibility for the Prize. In case of any disputes, the Bank’s decision shall be final and binding.
8. The Bank will offer the Prize on or before 30 April 2021.
9. Email or SMS notification of the Prize will be sent to the Eligible Client. Eligible Clients must maintain their up-to-date and valid personal information including valid email address or valid mobile number with the Bank by the time of offering the Prize, in order to receive the notification. If applicable, redemption procedures and available dates of the Prize will be explained in details in the notification and may be subject to additional terms and conditions as set out in the notification.
10. Eligible Clients who have terminated their banking relationship with the Bank at the time of offering the Prize will be disqualified from the Promotion.
11. The result of the Promotion will be announced on the Bank’s website at [sc.com/hk](http://sc.com/hk) after the Promotion Period by 31 March 2021.
12. Eligible Clients shall notify the Bank if they do not receive the notification for the Prize on or before 31 May 2021, otherwise, the Bank accepts no liability and will not be liable for any compensation.
13. The Bank also reserves the right to terminate the Promotion and to vary or modify any of the terms and conditions herein from time to time. In case of any disputes, the Bank’s decision shall be final and binding.
14. The Bank is not the supplier of the Prize provided under or in connection with the Prize under the Promotion. The Bank shall have no liability relating to any aspect

of the Prize provided by the supplier. The Prize may be subject to additional terms and conditions of the supplier.

15. Fraud and abuse will result in forfeiture of an Eligible Client's eligibility to the entitlement to the Prize. In case there is any suspected abuse, misuse or fraud which shall be determined at the sole discretion of the Bank, the Bank reserves the absolute right to forfeit the Eligible Client's eligibility to the entitlement to the Prize without prior notice.
16. OpenRice Promo Code can be used in OpenRice "Voucher" & "Takeaway" sections only.
17. Each OpenRice Promo Code can be used for once only.
18. Only one OpenRice Promo Code can be used in each single transaction.
19. Expiry date of OpenRice Promo Code will be on 30 September 2021.
20. OpenRice Promo Code is non-refundable and cannot be redeemed for cash.
21. The OpenRice Promo Code cannot be used in conjunction with any other promotion offer or promotional discount coupons, unless otherwise specified.
22. The transaction amount can be less than or equal to OpenRice Promo Code value. In this case, HK\$0.1 handling fee will be charged, and the remaining amount of Promo Code (if any) will be forfeited.
23. If there is any inconsistency or conflict between the English and the Chinese versions, the English version shall prevail.
