



## Terms and Conditions of Standard Chartered Smart Credit Card Limited Time Offer (“Limited Time Offer”)

- The Limited Time Offer is valid from 1 January to 30 April 2022 (both dates inclusive) (the “**Promotion Period**”).
- The Limited Time Offer is only applicable to cardholders (“**Cardholders**”, including both the principal and supplementary cardholders) of Standard Chartered Smart Credit Card (the “**Eligible Card**”) issued by Standard Chartered Bank (Hong Kong) Limited (the “**Bank**”).
- To be eligible for the Limited Time Offer and enjoy up to 7.44% CashBack on an Eligible Transaction (as defined below), Cardholders are required to make an Eligible Transaction with the Eligible Card during the Promotion Period. The Limited Time Offer comprises two reward categories including Eligible Merchant Transactions and Eligible Hotel Transactions. Details of the Limited Time Offer are as follows:-

CashBack will be offered ONCE only if the same Eligible Transaction falls under multiple reward categories.

\* Terms and conditions apply. 0.56% CashBack is equivalent to HKD1 CashBack for every HKD180 spent and has been rounded to nearest two decimal places. - Eligible Transactions** include Eligible Merchant Transactions and Eligible Hotel Transactions but do NOT include any unposted, cancelled, refunded, falsified or unauthorised transactions.

  - Eligible Merchant Transactions (“Limited Time Offer: Merchant”)** mean transactions made at Expedia Hong Kong in Hong Kong Dollars, and only single net spending amount after instant discount (if applicable) will be calculated.
  - Eligible Hotel Transactions (“Limited Time Offer: Hotel Category”)** mean transactions made at all local hotels including room reservation, room services, entertainment in hotel property and room reservation via online or offline travel agents in Hong Kong Dollars. They do NOT include transaction made with value stored gift voucher, hotel membership fee, hotel dining club membership. All hotel room reservation/hotel package MUST be used or completed on or before the last date of the Promotion Period. The last check-in date is **31 May 2022**. Eligible Hotel Transactions do NOT include transactions made with merchants with merchant codes not defined as hotel/travel agents/organizations (as defined by the Bank and Visa International), overseas hotel transactions, or individual merchants with merchant codes not defined by the acquiring banks as appropriate merchant codes of the relevant business or any unauthorized transactions. **Eligible Hotel Transactions do NOT include transactions made at KLOOK, which is a Designated Merchant under Rewards Scheme T&Cs.**
- Under the Limited Time Offer, Eligible Merchant Transactions and Eligible Hotel Transactions will be calculated and counted collectively. Together with the 0.56% CashBack (equivalent to HKD1 CashBack for every HKD180 spent) rewarded under the prevailing Smart Card Rewards Scheme, a Cardholder can only enjoy up to HKD800 CashBack throughout the entire Promotion Period. **For the avoidance of doubt, transactions made at KLOOK will be governed by the prevailing Smart Card Rewards Scheme and subject to the Rewards Scheme T&Cs.** For details, please refer to [sc.com/hk/credit-cards/smart/](https://sc.com/hk/credit-cards/smart/).
- No registration or minimum spending is required for the Limited Time Offer.
- The Limited Time Offer is applicable to merchants’ outlets in Hong Kong SAR only. Where Eligible Transactions are made using digital wallets, they will be eligible for the Limited Time Offer only if the merchant’s name is reflected on the credit card monthly statement as part of the transaction description.
- To be eligible for the Limited Time Offer, all Eligible Transactions must be completed and posted on or before **7 May 2022** based on the transaction dates as shown on the credit card monthly statement.
- The CashBack earned under Limited Time Offer will be shown on the 360° Rewards Redemption Platform on or before **30 June 2022**, and will not be automatically credited to the Eligible Card account, but can be freely redeemed for CashBack under the online catalogue of the platform. The CashBack will be given in Hong Kong dollars and the minimum threshold for CashBack redemption per Eligible Card account is HKD50 per account redemption. For details, please refer to the section named “CashBack Redemption” under the Terms and Conditions for Points Redemption.
- CashBack will be calculated by rounding down to the nearest 1 cent.
- Eligible Transactions conducted by principal and all supplementary cards (if any) under the same Eligible Card account will be counted collectively in calculating the CashBack.
- CashBack is non-transferable.
- Cardholders shall notify the Bank if they do not receive the CashBack by **31 July 2022**. Otherwise, the Bank accepts no liability and will not be liable for any compensation.
- In the event that any CashBack has been used or credited into Cardholders’ Eligible Card account but the transaction(s) that form(s) part or all of the Eligible Transaction(s) is cancelled or refunded subsequently, the Bank has the right to charge to the Eligible Card account a monetary amount equivalent to the value of the CashBack used or credited without prior notice to the Cardholders.
- If the Eligible Card account is voluntarily or involuntarily closed, all CashBack (whether credited to the Eligible Card account or not) will be immediately forfeited.
- The Bank reserves the right not to award any CashBack if the Eligible Card account is invalid or not in good financial standing at the time of rewarding the CashBack, or if the Cardholders have failed to pay any minimum payment due on or before the due date specified in the relevant monthly statement in the preceding 12 months.
- The Limited Time Offer shall be terminated immediately upon closure of the merchant(s).
- Cardholders understand and accept that the Bank is not the supplier of the products and/or services supplied by the merchant(s) under or in connection with the Limited Time Offer. The Bank shall bear no liability relating to any aspect of the products and/or services, including without limitation, their quality, the supply, the descriptions of products and/or services provided by the merchant(s), any false trade description, misrepresentation, mis-statement, omission, unauthorized representation, unfair trade practices or conduct in connection with the Limited Time Offer or in making available the products and/or services under the Limited Time Offer, by the merchant(s), its employees, officers or agents.
- Personal data of Cardholders may be collected by the merchant(s) and the use of such personal data shall be subject to the personal information collection statement of the merchant(s). Please contact the merchant(s) for related details.
- The Bank reserves the right to alter or terminate the Limited Time Offer and amend the terms and conditions herein at any time without prior notice. In case of disputes, the decision of the Bank shall be final and binding.
- In case of any disputes, Cardholders are required to present the relevant original sales receipts and credit card sales slips for further investigation by the Bank.
- These terms and conditions should be read together with the Terms and Conditions of 3-month unlimited Interest-free Instalment Plan for Standard Chartered Smart Credit Card, the Client Terms and the applicable documents referred to in part A of the Client Terms including the Credit Card Terms and the Terms and Conditions for Points Redemption that form the banking agreement between the Bank and the Cardholders.
- These terms and conditions shall be governed in accordance with the laws of the Hong Kong SAR and the Cardholders irrevocably submit to the non-exclusive jurisdiction of the competent court of the Hong Kong SAR.
- If there is any inconsistency or conflict between English and Chinese versions of these terms and conditions, the English version shall prevail.

## Smart 信用卡限時優惠之條款及細則（「限時優惠」）：

1. 限時優惠之推廣期由2022年1月1日至4月30日（包括首尾兩日）（「推廣期」）。
2. 限時優惠只適用於由渣打銀行（香港）有限公司（「本行」）所發行之渣打Smart信用卡（「合資格信用卡」）之持卡人（「持卡人」，包括主卡及附屬卡持卡人）。
3. 於推廣期內，持卡人須以合資格信用卡作合資格簽賬（定義如下）方可享限時優惠之高達7.44%現金回贈。限時優惠的兩個獎賞類別包括合資格商戶簽賬及合資格酒店簽賬，詳情如下：

4. **合資格簽賬**包括合資格商戶簽賬及合資格酒店簽賬，但不包括所有未誌賬/取消/退款/偽造/未經許可的交易。
  - a. **合資格商戶簽賬（「限時優惠之商戶」）**之定義為於香港Expedia的港幣簽賬，並將以扣除即時折扣（如適用）後之購買金額為準。

7. 此限時優惠只適用於商戶在香港特別行政區之各分店。如持卡人以電子錢包進行合資格簽賬，此限時優惠只適用於信用卡月結單上有顯示商戶名稱之交易。
8. 以月結單上的交易日期計算，所有合資格簽賬須於**2022年5月7日**或之前誌賬，方可參與此限時優惠。
9. 於限時優惠賺取之現金回贈將於**2022年6月30日**或之前顯示於「360°全面賞」網上換領平台，而不會自動存入合資格信用卡戶口。持卡人可隨時登入網上平台換領現金回贈。現金回贈將以港幣存入，每個合資格信用卡戶口之現金回贈換領金額最低為港幣50元。詳情請參閱積分換領之條款及細則之「換領現金回贈」條款部分。
10. 現金回贈將被調低至最接近之仙位數值。
11. 同一合資格信用卡戶口的主卡及所有附屬卡（如適用）之合資格簽賬將會一併計算現金回贈。

13. 客戶如在**2022年7月31日**仍未收受獎賞，須通知本行；否則，本行恕不承擔有關責任，也不會作任何賠償。
14. 如持卡人於任何現金回贈使用或存入後，取消或退款部份或全部與合資格簽賬有關之簽賬，本行有權從合資格信用卡戶口內扣除相等於該已使用或存入之現金回贈金額，而毋須預先通知。
15. 如取消合資格信用卡戶口（不論是自願或非自願），所有現金回贈（不論已否存入合資格信用卡戶口）將被即時取消。
