

Terms and Conditions

Liverpool FC Cashback Credit Card and Privilege Savings Account / Super Salary-i Account Bundle Acquisition Campaign (20th July – 31st October 2020)

Campaign

1. The Standard Chartered Bank Malaysia Berhad (“**SCBMB** or **the Bank**”) Liverpool FC Cashback Credit Card and PSA/Super Salary-i Account Bundle Acquisition Campaign (“**Campaign**”) will run from 20th July to 31st October 2020, inclusive of both dates (“**Campaign Period**”).
2. By participating in this Campaign, participants agree to be bound by all the Terms and Conditions below.
3. This Campaign Terms must be read with the respective product terms and the relevant banking agreements. If there are any inconsistencies between these terms and the relevant product terms and the banking agreement these terms shall prevail.

Eligibility

4. The Campaign is open to New to Product (“**NTP**”) customers who:
 - a) apply for and whose applications are approved by the Bank for the following products issued by the Bank (“**SCB Products**”) during the Campaign Period:
 - (i) Liverpool FC Cashback Credit Card (“**Liverpool FC Cashback credit card**”) AND
 - (ii) Privilege Savings Account (“**PSA**”) OR
 - (iii) Super Salary-i Account

and

(“**Eligible Customers/participants**”)

New to Product (“**NTP**”) means applicants who have not held any Liverpool FC Cashback credit card as principal cardholder within the past 6 months before the applicant's credit card under this Campaign is issued.

5. Eligible Customers whose credit card accounts are suspended, cancelled, or terminated for any reason during the Campaign Period or within 3 months after the end of the Campaign Period will not be entitled to receive any rewards under this Campaign.

Participation

6. To participate in this Campaign, Eligible Customers must:
 - (i) apply for Liverpool FC Cashback credit card and PSA/Super Salary-i Account during the Campaign Period via the dedicated roadshow venue (“**Successful Applicant**”); **and**

- (ii) have their applications successfully approved within the Campaign Period; **and**
- (iii) have their PSA / Super Salary-i account successfully opened during the Campaign Period; **and**
- (iv) activate and spend with their approved Liverpool FC Cashback credit card within 60 days from the credit card approval date

7. The Bank's decision on records of the application and approval dates will be final and conclusive.
8. The approval of each application is subject to the Bank's approving criteria.

 - (iii) The PSA / Super Salary-i Account must be successfully opened during the Campaign Period
