

## Marvel Avengers: End Game Movie Screening Event Terms and Conditions

### Event

2. By participating in this Event, participants agree to be bound by all the terms and conditions below. This Event Terms must be read together with the Marvel 2019 Campaign Terms and Conditions, product terms and the relevant banking agreements. If there are any inconsistencies between these terms and the relevant product terms and the banking agreement, these terms shall prevail limited only to the inconsistencies.

### Eligibility

3. This Event is open to: -
  - i) Selected Priority Banking clients with Standard Chartered Bank Malaysia Berhad (“Bank”) who received an invitation to attend the movie screening via short messaging services (SMS) between 8<sup>th</sup> April to 24<sup>th</sup> April 2019
  - ii) Other clients with the Bank who did not receive the SMS invitation to the movie screening are not eligible to attend the event.

### Event Details

4. This Event will take place at the following Golden Screen Cinemas (GSC) with screening details as per Table A.-

5. Eligible Clients are required to SMS back to 66399 the response “MA” to reserve two (2) complimentary movie tickets to the Event. The SMS response must be received by the Bank’s appointed SMS service provider no later than the date stipulated in the SMS message.
6. The Bank will provide the status of reservation to the Eligible Clients as defined in Clause 5 and Clause 6 within two (2) working days, from the original SMS date, in which:-
- (a) Eligible Clients who successfully secured the movie tickets will be notified
  - (b) Eligible Clients who fail to secure the movie tickets will be notified
7. Movie tickets will be given based on the sequential order from the first Eligible Client who successfully SMS back to 66399, until the capping amount as indicated in Table B below are exhausted. The appointed SMS service providers record as to time of submission shall be final and conclusive.

11. A standard charge of RM0.15 will be imposed by the telecommunication service provider for each successful SMS back to 66399.
