

**Revision on MyDream Account Campaign Terms and Conditions (Effective 1 July 2017)**

Please be informed that the following clauses of the MyDream Campaign Terms and Conditions have been revised. The revisions are unlined and indicated as per table below. The revised clauses will take effect from 1 July 2017 onwards until the end of the campaign.

<b>Clause 1: Campaign End Date</b>	Campaign ends 30 June 2017	Campaign ends <u>20 August 2017</u>
<b>Under “Interpretation (a)”</b>	Campaign months refers to February, March, April, May or June 2017	Campaign months refers to February, March, April, May, June, <u>July or August 2017</u>
<b>Clause 9: Letter of Gift Entitlement</b>	Letter of Gift Entitlement will be issued through the Bank’s branch to Eligible Account Holder who opened a new account and deposited or placed fresh fund through the Bank’s or SCSB’s branches.  The letter will state the Gift the Eligible Account Holder is entitled to. Through the letter the Eligible Account Holder must indicate his/her choice of Gift/s in	Letter of Gift Entitlement will be issued through the Bank’s branch to Eligible Account Holder who opened a new account and deposited or placed fresh fund through the Bank’s or SCSB’s branches; <u>or via the Bank’s authorized personnels who open accounts out-of-branch (“Employee Banking Personnel”)</u> .  The letter will state the Gift the Eligible Account Holder is entitled to. Through the letter the Eligible Account Holder must indicate his/her choice of Gift/s in

<p><b>Clause 10: Requirement to SMS</b></p>	<p>In the event the Eligible Account Holder did not submit the completed Letter of Gift Entitlement to the Bank / SCSB, the Eligible Account Holder is required to send an SMS to 66399 indicating his/her choice of Gift/s in accordance with the amount of Fresh Fund deposited.</p>	<p>In the event the Eligible Account Holder did not submit the completed Letter of Gift Entitlement to the Bank / SCSB / <u>Employee Banking Personnel</u>, the Eligible Account Holder is required to send an SMS to 66399 indicating his/her choice of Gift/s in accordance with the amount of Fresh Fund deposited.</p>
<p><b>Clause 15: Type of Tsum Tsum Gifts and Collection Period</b></p>	<p>There are in total six (6) types of Tsum Tsum to be given away during the Campaign Period in which the Ewok, Chewbacca, Storm Trooper Tsum Tsum will be given away from 20 February 2017 until 19 April 2017, while the Yoda, R2D2 and Darth Vader Tsum Tsum will be given away from 20 April 2017 until 30 June 2017.</p>	<p>There are in total six (6) types of Tsum Tsum to be given away during the Campaign Period namely the <u>Tsum Tsum Ewok, Chewbacca, Storm Trooper, Yoda, R2D2 and Darth Vader from 20 April 2017 until 20 August 2017.</u></p>

<p><b>Clause 21: Delivery of Gifts</b></p>	<p>The Gifts will be delivered to the Eligible Account Holder's address as maintained with the Bank or SCSB no later than 30<sup>th</sup> November 2017.</p>	<p>The Gifts will be delivered to the Eligible Account Holder's address as maintained with the Bank or SCSB no later than <u>31<sup>st</sup> December 2017</u>.</p>
<p><b>Clause 31: Star Wars R2D2 Droid Giveaway</b></p>	<p>To participate in the Star Wars R2D2 Droid Giveaway ("Giveaway"), Eligible Account Holders must be entitled to receive 6 Tsum Tsums and must maintain the balance in their MyDream Account / MyDream Account-i for three (3) consecutive months from the end date of the Campaign thereafter (from 30 June 2017 until 30 September 2017). Eligible Account Holders who fulfill this requirement will be assigned one (1) entry.</p>	<p>The Star Wars Smart R2D2 Giveaway comprises of <u>two (2) phases</u> with the following requirement:-</p> <p><u>Phase 1:</u></p> <p><u>28a) To participate in the Giveaway, Eligible Account Holders must be entitled to receive six (6) Tsum Tsums and must maintain the balance in their MyDream Account / MyDream Account-i for three (3) consecutive months from 30 June 2017 until 30 September 2017.</u></p> <p><u>28b) A total of fifteen (15) Star Wars Smart R2D2 ("Prize") will be given away during Phase 1.</u></p> <p><u>Phase 2:</u></p>

<p><b>Clause 40:</b> <b>Contest Prize (c)</b></p>	<p>One night accommodation (type of room will be subject to availability and decided by the bank) for three (3) pax (on sharing basis) in Disney's Hollywood Hotel.</p>	<p>One night accommodation (type of room will be subject to availability and decided by the bank) for three (3) pax (on sharing basis) in <u>Disney's Explorer Lodge Hotel.</u></p>
<p><b>Clause 41:</b> <b>Contest Travel Period</b></p>	<p>The Contest Prize travel period is valid from 1 August 2017 – 28 February 2018. Appeals for extension of travel period beyond 28 February 2018 will not be entertained.</p>	<p>The Contest Prize travel period is valid from <u>1 October 2017 – 31 March 2018.</u> Appeals for extension of travel period beyond <u>31 March 2018</u> will not be entertained.</p>
