

Terms & Conditions Excerpt

STANDARD CHARTERED BANK MALAYSIA BERHAD Spend & Redeem at SCKLM Race Entry Pack Collection (5 – 7 April 2018)

1. The Standard Chartered Bank Malaysia Berhad ("the Bank") "Spend & Redeem" ("Campaign") at SCKLM Race Entry Pack Collection in Hall 6 KL Convention Centre commences on 5 April 2018 and ends on 7 April 2018, both dates inclusive ("Campaign Period").
2. In order to participate in this Campaign, Eligible Standard Chartered credit cardholders must spend an accumulation of minimum RM200 or other banks' credit cardholder must spend an accumulation of minimum RM500 at any merchant stalls in Hall 6 KL Convention Centre using their credit cards within the Campaign Period to be entitled to redeem a SCKLM limited Umbrella or Towel ("Gift").
3. In meeting the minimum spend, Eligible Cardholders are not allowed to use vouchers and/or other in-store vouchers.
4. Eligible Cardholders are allowed to combine multiple receipts to meet one of the Minimum Spend Tier as listed in Clause 2 herein.

Campaign

- 1) The Standard Chartered Bank Malaysia Berhad ("the Bank") "Spend & Redeem" Campaign at SCKLM Race Entry Pack Collection ("Campaign") in Hall 6 KL Convention Centre commences on 5 April 2018 and ends on 7 April 2018, both dates inclusive ("Campaign Period").
- 2) By participating in this Campaign, participants agree to be bound by all the terms and conditions below.

Eligibility

- 3) This Campaign is open to :
Standard Chartered (SCB) credit cardholders of any SCB's card (other than corporate cards) issued by the Bank ("SCBMB Card") and who have maintained all their accounts with the Bank in good standing, without any breach of the terms and conditions or agreements, throughout the Campaign Period ("Eligible Cardholders")
- 4) Individuals below the age of 21 years are not eligible to participate in this Campaign.

Participation

- 5) In order to participate in this Campaign, Eligible SCB credit cardholders must spend an accumulation of minimum RM200 or other banks' credit cardholder must spend an accumulation of minimum RM500 at any merchant stalls in Hall 6 KL Convention Centre using their credit cards within the Campaign Period to be entitled to redeem a Gift as shown below.

- 6) In meeting the minimum spend tier, Eligible Cardholders are not allowed to use vouchers and/or other in-store vouchers.

Redemption

- 7) To redeem the Gift, Eligible Cardholders must present the Proof of Purchase from SCB credit card at the redemption counter.
- 8) Eligible Cardholders are allowed to combine multiple receipts to meet the Minimum Spend Tier as listed in Clause 5 herein.
- 9) Redemption must be made on the same day as purchase date with the last redemption at 8.00pm on 5 & 6 April 2018 and 6pm on 7 April 2018.

- 10) Redemption is limited to one (1) gift per customer and in sequential order from the first customer who fulfilled all the criteria until the capping quantity of Gift is exhausted. The available quantity of Gift available for redemption is limited to 600 units (200 units for Umbrella and 400 units for Towel) throughout the Campaign Period.
- 11) Gift accorded cannot be transferred, exchanged for cash or kind and extended beyond its expiry.

General

- 12) The Bank's record of details and transactions are final and conclusive for purposes of this Campaign.
- 13) The Bank's decisions relating to this Campaign are final and binding all participants. If any matters, dispute or claim arise which are not covered in these Terms and Conditions, they will be determined solely by the Bank.
