





# "Spot the Standard Chartered Cruiser Facebook Contest" TERMS & CONDITIONS

- 1. Standard Chartered Bank Malaysia Berhad (the Bank) is running the Spot the Standard Chartered cruiser Facebook content ("the Contest") from 26 February 12.00 a.m. and ends 31 March 2018 at 11.59pm ("Entry Period") both dates inclusive.
- 2. By participating in this Contest, participants agree to be bound by all the terms and conditions as stated herein.
- 3. This Contest Terms are to be read together with the Bank's respective Banking Agreements. If there is any inconsistency between these Contest Terms and other terms, these Contest Terms will prevail.

### **Eligibility**

- 4. The Contest is open to all Malaysian citizens and legal permanent resident of Malaysia who are 18 years of age or older and who have Facebook account at the date of entry. Employees of the Bank, the Bank's parent company, subsidiaries, affiliated companies, advertising or promotional agencies and the immediate families (defined as parents, spouse, children, siblings, grandparents) of such employee are NOT eligible. ("Eligible Participants")
- 5. To enter the contest, the "Photo Are Private" options in Facebook must be set to OFF. To enter the contest, Eligible Participants must follow the steps below:
  - i. Take a photo of the Bank's Standard Chartered Cruiser where you see it

  - iii. Tag your photo with #NoExcuse
  - iv. Eligible Participants may enter as many photos as they like as long as each photo is different. Photos must be uploaded in accordance with Facebook Terms and Policies. Each uploaded photo will be counted as one (1) "Entry" and is subject to the requirements outlined in Clause 7 below. All entries must be completed and received before 31 March 2018 at 11.59pm to be eligible for a prize.
  - v. Entries may only be submitted by a single registered Facebook user, group submissions are not permitted.

## **The Contest**

The winner must reply to winner notification from the Bank and inform the Bank their mailing address and email address within 48 hours of receiving the winner notification. If a winner is no reachable at the email address or mailing address provided or if prize notification is returned as undeliverable, then the prize will be forfeited and an alternative winner will be selected. Determination made by the Bank on matters relating to the Contest are final and conclusive.
