

## BVN Registration For Clients In Diaspora

Dear Valued Client,

As part of efforts towards finalising the implementation of the Biometric Verification Number (BVN) process, we are pleased to inform you that the Central Bank of Nigeria (CBN) has provided registration guidelines for clients residing overseas.

Clients in diaspora can now undertake BVN registration at an offshore branch of any Nigerian bank at no service fee.

Clients also have a choice of BVN registration through two service providers, **Online Integrated Solutions (OIS)** and **VFS Global**, the official consultants of the CBN.

To register through OIS, you are required to book an appointment at [www.oisservices.com](http://www.oisservices.com) and visit any of the below locations from the advised date.
