I hereby authorize Standard Chartered Bank to verify any information from whatever sources it may consider appropriate. I accept that Standard Chartered Bank is entitled in its absolute discretion to accept or reject this application without assigning any reason whatsoever and that the application and its supporting documents shall become part of the Bank's records and shall not be returned to me. I also agree that the Bank may engage an external service provider (including a credit reference agency) to undertake data entry and processing of my card application and transactions. I confirm and agree that the bank may give any information in connection with this application (including my personal information) to any service provider (whether located in or outside of Nigeria) for the purposes of providing any service to me in connection with this application (including data entry and processing of my card application and transaction) or credit card product features. I understand that the credit card terms and the card will be sent to me by courier or mail or will be collected by myself at my domicile branch upon approval by the bank. I acknowledge and agree that the use of the Primary Card and/or Supplementary Cards, if any issued on my account shall be deemed an acceptance of the terms and conditions of Bank's Credit Card Agreement (which may be amended from time to time) accompanying the card. Upon approval, I agree to pay the prevailing fees. By signing the application form; signing, activating or using the card, I agree to be bound by the terms and conditions as mentioned in the Bank's Credit Card Agreement.

I am fully aware that this application constitutes an application for credit and I will have to repay all amounts borrowed through the use of the Standard Chartered Credit Card, and that have the necessary means to repay these amounts within the prescribed period.

When requested, I authorize Standard Chartered Bank to issue Supplementary Card(s) for use on my account the person(s) named who I undertake, is/are over 18 years of age and agree that you may provide information to him/her about the supplementary card account. In case the Supplementary Card applicant is between 18 and 21 years of age, I hereby undertake that the use of such card shall be under my supervision and control. I hereby agree to indemnify the Bank against any loss, damage, liability or costs incurred by the Bank on account of the usage by me or the Supplementary Cardholder of the card or any breach of terms and conditions contained in the Bank's Credit Card Agreement or by reason of any legal disability or incapacity of the Supplementary Cardholder. I also understand that the Supplementary Card fees shall be billed in my statement and it shall be my primary responsibility to honour all charges incurred on the Supplementary Card. The continuation of membership of the Supplementary Cardholder(s), shall be dependant on the continuation of my membership.

The Credit Limit assigned on the card will be at the sole discretion of the Bank and shall be inclusive of the Credit Limit of the Supplementary Cardholder (if applicable). The Credit Limit can be increased, decreased or blocked at the Bank's discretion. The limit assigned is subject to any cash withdrawal and/or transaction limit set by the Central Bank of Nigeria from time to time.

I acknowledge that my card will be blocked ninety (90) days after issuance if I have not activated it and the cost of the card will be passed to my account.

I acknowledge that my card will be charged N1,000 (one-off) as Issuance fees when my card is created and this cost is also applicable to renewal or replacement card.

I acknowledged that my card will be charged 3% per month on purchases not cleared within fifty (50) day interest free period and 4% per month on cash withdrawal charged from the date of the transaction until the date of full repayment.
