# Annex C Vidsur Golf Terms & conditions

#### **Golf Course Rules & Regulations**

- 1. All customers will abide by the rules & regulations of the golf course part of the service. Customers will be solely responsible for their behaviour and actions on the golf course.
- 2. All bookings are subject to availability of the golf courses. The golf course is under no obligation to provide an alternate time.
- 3. Golfers Insurance or any other type of insurance is not included in the Golf service. All participating customers are responsible for their own insurance and for any possible injuries during the course of play.
- 4. Golf courses have the right to change their green fees without any notice. All discounts will be applicable on the green fee applicable on the date of the customer making the booking.
- 5. Golf courses have the right of refusal to all customers. Golf courses may ask to remove or suspend play for any customer on the golf course.
- 6. Golf Courses have a right to ask for a valid Handicap Certificate and/or an identification ID from the customers.
- 7. All customers will abide by the dress code of the applicable golf course. In General, the dress code is Shirts / T-shirts with collars and sleeves, trousers or golf shorts and golf shoes. Players are not permitted to wear round neck, sleeveless shirts / T-shirts without collars, sweatpants, jeans, cut offs, athletic shorts, sports shoes, tank tops and golf shoes with metal spikes.
- 8. All customers will have to abide by the etiquettes of the golf course.
- 9. Raincheck is at the sole discretion of the golf course.
- 10. Vidsur does not provide any guarantee/ level of Service standards of the listed golf courses. Any complaints regarding the services provided by the golf courses will not be entertained by Vidsur.
- 11. All customers will have to report before/on the stipulated time of the booking. Late arrivals/reporting may lead to cancellation of booking.

#### **Cancellations, Changes & No Shows**

#### Changes/Cancellations

- 12. Changes in timings of any weekday and weekend/holiday bookings will be subject to availability.
- 13. The golf course/golf coach has the right to reject any changes to the bookings. All such unavailable change request bookings will stand confirmed on the original booking time.
- 14. Cancellation Conditions for Discounted games

#### Weekday:

- a. Cancellation must be made more than 48hrs in advance to tee time.
- b. In case of breach of the above 48hrs notice, a cancellation charge of 100% of the walking green fee of the golf course will be applicable.

#### Weekend/Holidays

- a. Cancellation must be made than 48hrs in advance of the tee time.
- b. In case of breach of the above 48hrs notice, a cancellation charge of 100% of the walking green fee of the golf course will be applicable.
- 15. Cancellation Conditions for Complimentary games



#### Weekday:

- a. Cancellation must be made more than 48hrs in advance to tee time.
- b. In case of breach of the above 48hrs notice, the booking will be counted as a used / completed booking.

#### Weekend/Holidays

- c. Cancellation must be made than 48hrs in advance of the tee time.
- d. In case of breach of the above 48hrs notice, the booking will be counted as a used / completed booking.

#### 16. No Shows

a. All no shows for all bookings will be treated as a completed booking. No refund/cancellation charge will be applicable and 100% of the green fee paid by the customer will be forfeited.

#### **Booking Conditions**

- 17. The minimum required for a weekday booking is 1(one) to (2) ball (person). Booking system will update each club's minimum requirement automatically online during time of booking.
- 18. The minimum requirement for a weekend booking is 3(three) ball (person).
- 19. The minimum number of players required per flight is 2 persons for weekday and 3 persons for weekend.
- 20. For weekend bookings, the customer may choose to join other customers or join members of the golf clubs.
- 21. For weekend bookings, the names of the other customers/members will be required at the time of booking to process the booking. For clarity, the additional names provided will not be considered under the 4 times complimentary golf games that customer is entitled to during the Promotional Period.
