1 Letter of Authority & Indemnity for the Appointment of Authorised Representative

 - To draw on my Account(s) by signing or endorsing cheques, withdrawal slips, orders for transfers orders for payments or otherwise for any purpose and in any manner whatsoever (including orders for payment to the Authorised Representative or orders for transfer of moneys to the account of the Authorised Representative) so that the Bank shall not be concerned to see to the application of such payments or transfers and notwithstanding that the debiting of my Account(s) be overdrawn or cause any overdraft to be increased thereby.
 - To ask for and receive from the bank any and all information whatsoever relating to my Account(s) including but not limited to statements and statements of Account(s) and all other notices and documents relating to my Account(s).
 - To give the Bank ANY and ALL instruction whatsoever in relation to my Account(s), including without prejudice to the generality of the foregoing, where the Account(s) is/are Time Deposit account(s). Instructions relating to (but not limited to) renewals, maturity periods and upliftments (partial or otherwise), and regardless whether the foregoing instructions results in any change in account number(s).
- that all acts and matters within the scope of powers hereinbefore mentioned heretofore done by the Authorised Representative for me in relation to my Account(s) are hereby ratified and confirmed and that I will rectify all acts and matters within the scope of the said powers which may hereafter be done by the Authorised Representative for or on my Account(s).
 - that this authority is in addition to and in no way limits or restricts any rights which the Bank may have under any other agreement or agreements between me and the Bank.
 - that in the event of my death, the acts of the Authorised Representative shall be binding upon my executors or administrators (as the case may be) and all other persons claiming from or under me until notice in writing of such death shall have been given to the Bank by some party entitled to give notice.
 - that the appointment of the Authorised Representative hereunder has been made by me out of my own free will and as a result of my own judgment and deliberations and the Bank shall be under to liability whatsoever in respect of any loss or damage which I may suffer or incur as a result of these acts or omissions of the Authorised Representative and I shall be fully responsible for such acts or omissions of the Authorised Representative and agree to keep the Bank fully and effectually indemnified against any losses, damages, costs or expenses which the Bank may suffer or incur whatsoever in connection with such acts or omissions of the Authorised Representative and in accepting this authority herein from me.
 - that the powers hereby conferred upon the Authorised Representative shall be given the widest interpretation, and that I agree that the Bank's interpretation of the powers hereby conferred upon the Authorised Representative shall be final and conclusive and binding upon me and I further agree to keep the Bank fully and effectually indemnified against all losses, damages, costs or expenses which the Bank may suffer or incur whatsoever in connection with this authority herein.
 - that the authority herein contained shall remain in full force and effect until such time as the Bank receives written notice or revocation from me.
 - that I have read and understood fully all of the Bank's prevailing terms and conditions as set out in the Bank's applicable terms and conditions entered into with the Bank as the same may be updated or amended from time to time, and agree to be bound by them in connection with all my existing accounts with the Bank as well as any and all accounts whatsoever with the Bank that may hereafter be opened by me or by the Authorised Representative on my behalf.
