

Rewards+ Card Upsized Gift Promotion 2018 Terms and Conditions

Eligibility

1. The Rewards+ Card Upsized Gift 2018 ("**Rewards+ Upsized Gift Promotion**") is available from 3 May to 31 July 2018 (both dates inclusive) ("**Promotion Period**"). The Rewards+ Upsized Gift Promotion is open to all eligible principal cardholders of the Standard Chartered Rewards+ Credit Card ("the **Rewards+ Card**") issued by Standard Chartered Bank (Singapore) Limited ("**Bank**") (collectively, "**Rewards+ Cardholders**"). By participating in the Rewards+ Upsized Gift Promotion, Rewards+ Cardholders agree to be bound by these terms and conditions.
2. Unless otherwise stated, the Rewards+ Upsized Gift Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions. The Rewards+ Upsized Gift Promotion is valid in conjunction with the Standard Chartered Caltex 2018 Promotion (the terms and conditions of which can be found [here](#)), The Standard Chartered and Grab April 2018 Promotion (the terms and conditions of which can be found [here](#)) and The Good Life® 2018 Promotion (the individual merchant and general terms and conditions of which can be found [here](#)).
3. Rewards+ Cardholders whose Cards' accounts have been suspended, cancelled or terminated for any reason during the Promotion Period and until 31 August 2018 are not eligible for the Rewards+ Upsized Gift Promotion.

Participation

4. To participate in the Rewards+ Upsized Gift Promotion, Rewards+ Cardholders must:
 - a. successfully register their Rewards+ Card from 3 May to 31 July 2018 (both dates inclusive) ("**Registration Period**") by sending an SMS in the format set out in Clause 6 below ("**SMS Registration**") (such successfully registered card hereinafter referred to as a "**Registered Rewards+ Card**");
 - b. the Registered Rewards+ Card must be eligible for the Rewards+ Upsized Gift Promotion (see Clause 3 above for eligibility requirements);
 - c. agree for the Bank to deduct a total of 5,000 rewards points awarded under the Standard Chartered 360° Rewards Programme ("**Rewards Points**") from their Registered Rewards+ Card account for the Rewards+ Gift (as defined in Clause 10 below) in accordance with the promotion mechanics listed out in Clause 10 below;
 - d. have 5,000 Rewards Points in their Rewards+ Card account as of 31 July 2018; and
 - e. maintain at least 5,000 Rewards Points in their Rewards+ Card account at the point of deduction pursuant to this Rewards+ Upsized Gift Promotion.
5. The Rewards+ Upsized Gift Promotion is limited to the first 800 registrations received by us via SMS Registration during the Registration Period. The Bank will not accept any:
 - a. Attempts to register before and/or after the Registration Period;
 - b. Registrations after the first 800 registrations; and
 - c. Registrations that are not in the prescribed format (as set out at Clause 6 below).

All such registrations will be considered by the Bank to be invalid and/or void, and the Bank's determination shall be final and conclusive.

6. For SMS Registrations, all SMSes must be composed in the following format:

"Upsize" (Example: Upsize).

The composed SMS must be sent to 77222. All SMS Registrations which are not in this prescribed format will not be accepted and will be considered by the Bank to be invalid and/or void. The SMS must be sent from the Rewards+ Cardholder's Bank registered mobile number and each such registration SMS will only result in registration for this Rewards+ Upsize Gift Promotion for the Rewards+ Card associated with such registered mobile number. Successful registration for this Rewards+ Upsized Gift Promotion results in automatic deduction of the Rewards Points required for the Rewards+ Gift (as defined in Clause 10 below) if the Registered Rewards+ Card account has 5,000 Rewards Points as at 31 July 2018 (Friday) and also at the time the deduction of the 5,000 Rewards Points is effected by the Bank.

7. An acknowledgement of successful registration will be sent to the mobile number which the Rewards+ Cardholder had used for his/her registration.
8. The speed and reliability of service of the Rewards+ Cardholder's mobile connection is dependent solely on his/her respective mobile service providers. The Bank is not responsible or liable in any manner whatsoever for any delay or failure in the transmission or receipt of any SMS Registration, or any failure to register resulting from the same. Rewards+ Cardholders shall be solely responsible for all fees and charges imposed by their service providers in the SMS Registration.
9. By registering for the Rewards+ Upsized Gift Promotion and participating in the Rewards+ Upsized Gift Promotion, the Rewards+ Cardholder consents to the use of his/her personal data for marketing purposes, including but not limited to the use of his/her telephone number to contact him/her about products and promotions offered by the Bank from time to time via telephone, SMS or multimedia messaging. Such consent will also prevail even if the Rewards+ Cardholders is registered or subsequently registers his/her contact information with the national Do Not Call Registry.

Promotion Mechanics

10. To qualify for the Rewards+ Upsize Gift Promotion, the Rewards+ Cardholder must:
- successfully register for the Rewards+ Upsized Gift Promotion;
 - be within the first 500 Rewards+ Cardholders to accumulate 5,000 Rewards Points on their Registered Rewards+ Card account;
 - agree for the Bank to deduct 5,000 Rewards Points from their Registered Rewards+ Card account;
 - have 5,000 Rewards Points in their Rewards+ Card account as of 31 July 2018; and
 - maintain at least 5,000 Rewards Points in their Rewards+ Card account at the point of deduction pursuant to this Rewards+ Upsized Gift Promotion.

Upon the successful deduction of the 5,000 Rewards Points from the Registered Rewards+ Card, each Rewards+ Cardholder will be eligible to receive a 30" American Tourister Luggage Bag ("**Rewards+ Gift**").

11. A deduction of 5,000 Rewards Points will take place upon the Bank confirming the eligibility of the Rewards+ Cardholder for the purpose of the Rewards+ Gift and the deduction will take place no later than 18 August 2018. If, at the point of deduction of the Rewards Points, the Rewards+ Cardholder has less than 5,000 Rewards Points, the Rewards+ Cardholder would not have

fulfilled the requirement found in Clause 4(e) above and thus would be ineligible for the Rewards+ Upsized Gift Promotion. Subsequently, the Rewards+ Cardholders who have qualified to receive the Rewards+ Gift will receive a letter which can be used to redeem the Rewards+ Gift no later than 31 August 2018.

General

12. The Bank is not responsible for any failure or delay in the transmission of the transactions by any party including but not limited to Mastercard/Visa acquiring merchants, merchant establishments, any telecommunication provider, any internet service provider or website.
13. Rewards Points accumulated by the supplementary cards of a Rewards+ Card account will count towards the 5,000 Rewards Points qualifying condition for the purposes of the Rewards+ Upsized Gift Promotion.
14. The Bank reserves the right to revise these terms and conditions, modify or withdraw the Rewards+ Upsized Gift Promotion at any time without prior notice or reason including terminating, shortening, extending or withdrawing the Rewards+ Upsized Gift Promotion and/or substituting the Rewards+ Gift with any other item (which may or may not be of equivalent or similar value), without prior notice or reason.
15. The Bank accepts no liability for the goods and services provided by any merchant or service provider. Any dispute about the same must be resolved directly with the merchant or service provider. In case of any disputes, the decision of the Bank and the respective merchants, or service providers shall be final.
16. The Bank is not an agent of any merchant or service provider or vice versa.
17. The Rewards+ Gift is non-transferable, non-assignable and non-exchangeable for cash or credit or otherwise.
18. The Bank reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Rewards+ Upsized Gift Promotion. The Bank's determination of all matters relating to the Rewards+ Upsized Gift Promotion shall be final and binding, and no correspondence will be entertained.
19. In the event the Bank has determined that a Rewards+ Cardholder has irregularly or wrongly received the Rewards+ Gift from the Bank, or where the Bank has knowledge of subsequent events which would mean that the Rewards+ Cardholder would not have been entitled to receive the Rewards+ Gift (including but not limited to where the charges for the Qualifying Transaction were reversed or refunded), the Bank reserves the right to deduct the value of the Rewards+ Gift from the Rewards+ Cardholder's account(s) with the Bank. For the purposes of deducting the value of the Rewards+ Gift from the Rewards+ Cardholder, each participant authorizes and consents to the Bank debiting the value of the Rewards+ Gift from any of his/her/their credit card accounts.
20. In the event of any inconsistency between the Rewards+ Upsized Gift Promotion Terms and Conditions and any brochures, marketing or promotional materials relating to the Rewards+ Upsized Gift Promotion, these Rewards+ Upsized Gift Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
21. Please read these terms and conditions together with our Customer Terms and Credit Card Terms, the Standard Chartered 360° Rewards Programme Terms and Conditions, the Standard Chartered Rewards+ Credit Card Promotion Terms and Conditions and any other product terms that may be

applicable in conjunction with the Rewards+ Upsized Gift Promotion (collectively "**Other Terms**"). In the event of any inconsistency between these terms and the Other Terms, these terms prevail only to the extent of such inconsistency.

22. A person who is not a party to these Rewards+ Upsized Gift Promotion Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of the Rewards+ Upsized Gift Promotion Terms and Conditions.
23. The Rewards+ Upsized Gift Promotion Terms and Conditions are governed by and shall be construed in accordance with the laws of the Republic of Singapore and you agree to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
