### **Important Details**

1. This offer is only available to tourists visiting Hong Kong excluding those residing in China and Macau (“Eligible Guests”).

12. The offer tickets may, on the visit date only, be upgraded to Magic Access by paying the applicable price difference at Magic Access Member Service Center in the Park. The applicable price difference depends on the offer ticket purchase price and the type of Magic Access Membership Card selected. If the selected Magic Access Membership Card is priced lower than the offer ticket to be upgraded, no refund will be made.
13. Any Magic Access issued upon upgrade will be valid for one year starting from the date when the offer ticket was first used. No upgrade will be possible after the day when the offer ticket is first used.
