Important Details

1. This offer is only available to tourists visiting Hong Kong excluding those residing in China and Macau (“Eligible Guests”).
2. To enjoy this offer, Eligible Guests are required to complete payment for purchase of tickets to the Park using credit or debit cards issued by the following Standard Chartered entities (“Eligible Cards”):

3. This offer is available to Eligible Guests online from the website (the “Website”) designated by Hongkong International Theme Parks Limited (“HKITP”) and Eligible Guests are required to provide names, Eligible Card’s information and other forms of personal data as HKITP may require.
4. Eligible Guests are required to present (i) the confirmation issued by HKITP, and (ii) personal identification mentioned in paragraph above; and (iii) the Eligible Card used for the offer purchase upon Park admission.
5. Each Eligible Guest may only purchase up to 4 offer tickets in each transaction under this offer. This offer is only applicable to general admission and child tickets, and excludes senior tickets.
6. Each Eligible Guest is required to enter the Park together with his/her guests using the offer tickets. Guests cannot use the offer tickets without the presence of the Eligible Guest who purchased the offer tickets.
7. Offer tickets and offer items not redeemed or used on or before the last date of the offer period will be void without refund or compensation.
8. The offer items can be redeemed by presenting the offer ticket and voucher (if applicable) at the time of ordering and payment.
9. Redemption of the offer items are subject to the availability of such items and the operating hours of the designated location(s).

Ticket Terms and Conditions

11. The offer tickets may, on the visit date only, be upgraded to a 2-Day ticket by paying the applicable price difference. For the avoidance of doubt, upgrade to 2-Day tickets may only be made with unused offer tickets.
12. The offer tickets may, on the visit date only, be upgraded to Magic Access by paying the price difference at Magic Access Member Service Center in the Park. Any Magic Access issued upon upgrade will be valid for one year starting from the date when the offer ticket was first used. No upgrade will be possible after the day when the offer ticket is used.
