

## **Standard Chartered Cards Exclusive: Room and 1-Day Tickets Package**

### **Important Details:**

1. This offer is only available to tourists visiting Hong Kong excluding those residing in China and Macau (“Eligible Guests”).
2. To enjoy this offer, Eligible Guests are required to complete payment for purchase of this offer using credit or debit cards issued by the following Standard Chartered entities (“Eligible Cards”):
  - Standard Chartered Bank Korea Limited
  - Standard Chartered Bank (Taiwan) Limited
  - Standard Chartered Bank (Singapore) Limited
  - Standard Chartered Bank Malaysia Berhad
  - Standard Chartered Bank Indonesia Branch
  - Standard Chartered Bank (Vietnam) Limited
3. This offer is available to Eligible Guests online from the website (the “Website”) designated by Hongkong International Theme Parks Limited (“HKITP”). Eligible Guests are required to provide names and other forms of personal data as HKITP may require.
4. Eligible Guest must be one of the staying guests, and is required to present the Eligible Card used for the offer purchase and personal photo identification for verification at the time of check-in at the Hotel.
5. Actual package price depends on the check-in and check-out date, the room category selected, the group mix and the Hotel’s Best Available Rate, which is determined at the time of booking (subject to availability and any Benefits Limits, defined in the Hotel General Terms and Conditions).
6. Each Hotel Room can accommodate up to a maximum of 4 Guests. At least one adult must be a staying guest in each Hotel Room.
7. For bookings with check-in dates from April 1, 2018 onwards, an extra charge of HK\$200 per person per night will be imposed for the third and fourth Guest aged 12 or above per Hotel Room. The extra charge covers only the Hotel accommodation fee of the Guest, but does not include any other package components.
8. The price of the package includes 10% service charge based on the sum of discounted room rate and extra charge (if any).
9. A deposit equivalent to one package price and extra charge (if any) will be charged for each package reservation at the time of booking if check-in dates fall within the following period(s):
  - a. February 16 – 20, 2018.
10. Save and except for the dates referenced in paragraph 5 above, full payment of the package reservation will be charged upon arrival.
11. Guest is required to provide information including his or her name and credit card details for guarantee or deposit upon reservation.
12. No change of guest name is allowed under any circumstances.
13. Guest may cancel or amend the reservation at least 3 days prior to the check-in-date, except for February 16 to 20, 2018 and March 31, 2018; in which case cancellation or amendment has to be made at least 7 days in advance. An amount representing the full price of one package and extra charge (if any) will be charged in case of any cancellation made after the prescribed period stated above or no show. Amendment of reservation is subject to availability and Benefit Limits, and no change is permitted after prescribed period stated above.
