

Terms & Conditions

1. Campaign period:

From 24th Aug 2020 to 23rd Sep 2020, both days inclusive (“Campaign period”).

2. Criteria of Existing Client (who refers Auto Loan client to the bank):

Existing to Bank client who qualifies the following criteria:

- (i) Existing client who has any product at bank (CASA, Credit Card, lending products...)
